1.	I will not touch or chase the turtles.			
2.	I will not deliberately touch any corals on the reef.			
3.	I will not snorkel, sea diving or sea sports close enough to the reef to cause damage to it with my fins or camera equipment.			
4.	I will not hold onto, rest upon, stand or kneel on any part of the coral reef.			
5.	I will not rest any camera equipment on the coral reef.			
6.	I will comply with the Dive Guides instructions to move back from the reef.			
7.	If I am seen to be deliberately disregarding any of the above rules, I understand that I will be given a verbal warning from the Resort Manager.			
8.	If I am seen to deliberately damaging the reef after I have been given a verbal warning, Iwill be asked to stop snorkeling, skin diving or sea sports activities in SMART.
